Dear Permit Holder/Owner

The enclosed documents are to inform you of increases to the Abington Board of Health permits and fee schedules. In addition to the increase we have added several new permits and fee's to our list. Please be sure to review the list to insure that you are aware of any changes that may affect your business.

The Board of Health held an open public hearing regarding these changes on June 21, 2010. At this meeting the Board voted to approve this fee schedule and effect date. These additions are necessary to bring Abington to the same levels as surrounding towns. All increases are effective July 1, 2010.

In addition we will now have all licenses/permits begin on the same date. All licenses /permits will require renewal on January 1, 2011 with an expiration date of December 31, 2011. Any licenses/permits scheduled to renew or recently renewed will be billed pro-rated for the January 1, 2011 effective date.

Application for licenses/permits must be submitted to the health department with-in 30 days of expiration date (December 31, 2010) **or a late fee will be charged**. While we understand that this new process may create some confusion with this year's renewals, the January 1 effective dates will make the Board of Health more efficient.
